Dear Congressman Frelinghuysen,

We write as constituents of NJ's 11th Congressional District (CD), representatives of 29 groups whose membership includes tens of thousands of your constituents, and New Jersey residents you represent as a member of the US House of Representatives and chair of its Appropriations Committee to request a meeting with you before it is too late to discuss, and urge you to take a strong leadership role in stopping, the Trump Administration's proposed and absolutely devastating cuts to critical environmental, energy, and public health programs that protect clean air and water and provide public safety against property damage from extreme weather in your district and beyond.

The proposed cuts are so severe in their depth and breadth, even if partially scaled back, that they will roll back 47 years of progress and decimate core environmental protections. New Jersey will be especially hard hit because roughly 30% (\$190+ million) of NJDEP's funding comes from federal sources, and the environment is one of the few areas where New Jersey gets a fairer share of federal resources. Among our gravest concerns in the proposed FY2018 budget are:

- The 31% cut overall to USEPA (\$2.6 billion) including the total elimination of the Lead Risk Reduction Program, Office of Environmental Justice, Chemical Safety Board, National Estuary and NJ Sea Grant Program (including for Barnegat Bay, Delaware Bay and the NY-NJ Harbor & Estuary Program), and BEACH water quality testing.
- Specific cuts to core USEPA programs -- state grants (50%), clean air (41%, \$160 million), clean water (37%, \$320 million), and Superfund (30%, \$330 million, NJ has the most Superfund sites [100+] in the country).
- 69% cut to US Dept. of Energy's Office of Energy Efficiency & Renewable Energy (\$636 million) and offshore wind and solar power subsidies and tax credit programs.
- The total elimination of Energy Star (\$493 million), Green Climate Fund and Global Climate Change Initiative (\$1.59 billion), Advance Research Projects Agency, and Advanced Technology Vehicle Manufacturing loans (\$398 million).
- Pushing seismic testing in the Atlantic, opening up Alaska's Arctic National Wildlife Refuge (ANWR) for oil drilling, selling half of the nation's Strategic Petroleum Reserve (687.7 million barrels) and reviving Yucca Mountain Nuclear Waste Repository.

As chair of the House Appropriations Committee and lifelong New Jerseyan whose family has helped lead this country for generations, you are uniquely positioned to be a

difference maker in stopping these devastating cuts.
